Duties and responsibilities of the role may include:

- Perform the evaluation and interpretation of clinical pathology in preclinical studies.
- Analyze and interpret results obtained from clinical standard investigations applied to safety assessment studies including hematology, clinical chemistry, urinalysis, quantitative and qualitative evaluation of peripheral blood and bone marrow smear.
- Author comprehensive narrative reports of clinical pathology data while meeting report deadlines.
- Collaborate with anatomic pathologists in correlating clinical pathology and histopathologic findings on safety assessment studies.
- Prepare, maintain, organise study records in compliance with regulatory standards.
- Provide scientific and technical advice on clinical pathology to the clinical pathology technicians to ensure accuracy and compliance with protocols and SOP's.
- Maintain collaborative relationships with internal and external clients in order to ensure client satisfaction with the Clinical Pathology Laboratory deliverables.
